Your Vote is your voice being heard. Be heard on July 15<sup>th</sup>!

Going out of town or busy on July 15<sup>th</sup>? Here is some information that may be helpful.

### Early Voting Information:

EARLY VOTING takes place from Monday, July 7, to Friday, July 11. At the advance voting office, you must fill out an application and provide one of the permitted forms of Voter Identification. You will then be issued a ballot that must be filled out and cast while you are in the office.

### Want to Vote Absentee?

To vote ABSENTEE by mail, you must submit an application. Absentee ballot applications are available at both the DeKalb County website (<https://dklbweb.dekalbga.org/voter>) and Secretary of State website ([http://sos.georgia.gov/elections/absentee\\_voting.htm](http://sos.georgia.gov/elections/absentee_voting.htm)) or by contacting the DeKalb County Voter Registration & Elections Office at 4380 Memorial Drive, Decatur, GA 30032, Phone: 404-298-4020. You can request an application now.

Mail or hand-deliver your application to the DeKalb County Voter Registration & Elections Office at 4380 Memorial Drive, Decatur, GA 30032.

You may also fax your application to: 404-298-4038.

Please Note: Absentee ballot request forms should be received by the county at least ten days prior to the election to allow them to mail the ballot to you and you to return the ballot. Absentee ballots must be received by the DeKalb County Voter Registration & Elections Office by 7:00 p.m. on election day.
